**PROHIBITED**

- Breakables (all glass/ceramic items)
- Any electrical or gas cooking equipment
- Sound systems or speakers that are larger than a shoebox size
- Pets
- No outside alcoholic drinks allowed. Light beer available for sale inside the resort. No hard liquor.
- Firearms, weapons and ammunitions
- Any illegal, prohibited and/or regulated drugs and substance trade or use
- Gambling, prostitution
- Smoking & vaping is strictly prohibited inside all guest rooms and public areas of the resort except in designated outdoor smoking areas.

**ATTIRE**

Guests are requested to wear proper swimming attire such as swimsuits/bathing suits, Lycra or spandex board shorts, rash guards and other similar nylon swimwear before entering the pool. Clothing with buttons, zippers, metal components and denim material are prohibited.

**FOOD**

Guests can bring their own food and non-alcoholic drinks. They must be place in non-breakable containers (ex. plastic, aluminum). Charges will apply to catered food, food carts and electrical use. There are free charcoal grilling stations and washing stations inside the resort.

**SUPERVSION OF MINORS & GUESTS WITH SPECIAL NEEDS**

Lifeguards are here to help but they cannot take the place of a parent or guardians in supervising and safeguarding children & guests with special needs. All children and persons with physical or mental disabilities must be accompanied by their parents or adult guardians at all times.

**EXCLUSION CLAUSE**

The management shall not at any time be liable for any loses, injury or damage to person (fatal or otherwise) and or to property of whatever nature or kind. This covers areas inside the resort and parking area. First aid will be provided.

**DAMAGES TO PROPERTY**

Any damage or loss of resort property shall be charged to the registered guests.

**HEALTH CONDITIONS**

For the safety of all guests, persons with open wounds, skin diseases, nasal or eye discharge, or any communicable disease, is not allowed to use the pool.

**REFUSED ENTRY & EXPULSION FROM PROPERTY**

Guests who are under the influence of alcohol, illegal drugs, exhibit disruptive or destructive behavior or fail to follow the resort Terms & Conditions will be refused entry or requested to leave the property and may be prosecuted for offenses committed in our facilities.

- Change the operating hours of the resort and attractions
- Close the resort or any part of it temporarily for the day
- Restrict the number of guests having access to the resort
- Close any attractions or cancel entertainment program or events
- Close the resort due to inclement weather
